## LIABILITY AGREEMENT/ NO-WARRANTY ACKNOWLEDGEMENT

In consideration for the approval of my application to purchase a rifle, parts, accouterments, ammunition and/or components through the Civilian Marksmanship Program, I hereby agree to:

1. Waive any claim against the corporation for the promotion of rifle practice of firearms safety, its directors, officers, employees, volunteers, agents and contractors (collectively, "CPRPFS") for any personal injury, loss, damage or expense that I might incur arising from the use of this rifle, parts, accouterments, ammunition and/or components, and
2. Defend, indemnify and hold the CPRPFS harmless from any claim of a third party arising from the use of this rifle, parts, accouterments, ammunition and/or components including any expense incurred by the CPRPFS in defending, investigating or settling such a claim.

I agree that this agreement and legal issues arising from the sale of this rifle, parts, accouterments, ammunition and/or components to me shall be governed by the law of the state of Ohio; and that if any provision of the agreement or its application to any person or circumstance is held invalid or unenforceable, the remainder of this agreement or the application of such provision to other persons or circumstances shall be unaffected. I further agree that this agreement shall be binding upon my executors, administrators, trustees, personal representatives and assigns.

I also acknowledge that the rifle which I am applying to purchase is a military surplus arm in used condition and is sold to me strictly "AS IS", WITH NO WARRANTY EXPRESS OR IMPLIED. I understand that:

1. This rifle may not function properly or be safe for me to use in the condition in which I receive it.
2. This rifle is not to be fired until it has been disassembled and cleaned, thoroughly examined by a competent gunsmith familiar with its internal mechanism and safety features, and any unserviceable parts replaced or other deficiencies corrected.
3. The use of ammunition that does not meet U.S. military standards in this rifle can be dangerous.

**VOLUNTARY RELEASE AND WAIVER OF LIABILITY**  
**ADVANCED MAINTENANCE CLASS**

**PLEASE READ CAREFULLY**

I, \_\_\_\_\_, the participant/student at the Advanced Maintenance Class freely and voluntarily, without duress or mental reservation, **assume any and all known or unknown risk of harm that may arise during my participation in this activity provided by the Civilian Marksmanship Program (hereafter called CMP).**

I hereby execute this Release and Waiver of Liability under the following terms:

**A. Activities.** I acknowledge that I will be involved in activities that may:

1. include handling and discharge of firearms either by myself or by others.
2. include handling and discharge of ammunition.
3. include traveling to a facility either at or away from a CMP facility.
4. include the use of mechanical devices
5. take place with other untrained persons.
6. involve the assembly of firearms
7. involve the use of machines or other mechanical devices

**B. Assumption of Risk.** I understand that my participation in the Advanced Maintenance Class with the Civilian Marksmanship Program may include activities that may be hazardous or inherently dangerous to me. I expressly assume the risk of any illness, injury, permanent disability or death in the activities and release the Civilian Marksmanship Program from all liability for injury, illness, death and/or property damage that may result. I understand that I am engaging in activities at my own risk and I am subject to the rules, guidelines, and policies of the Civilian Marksmanship Program. **This means that I know the risks involved in the projects, activities and events conducted by CMP. This also means that with this knowledge, and after consideration of what might happen to me if I participate in CMP's Advanced Maintenance Class, I knowingly assume the risk of illness, injury, serious injury or permanent disability or death and I wish to participate in the program. This also means that I recognize that there may be risks that are not known to either CMP or myself, and that may occur while I am participating in the program. I know that such unknown risks exist, and I am willing, and hereby do, voluntarily assume those risks and their consequences including injury, illness, permanent disability or even death. This also means that I will follow rules, guidelines, instructions and policies of CMP while I am a participant in the program. I also assume the risk that CMP or anyone associated with CMP may be negligent, but I do not assume the risk that CMP or anyone connected with CMP will be grossly negligent or intentionally cause injury, illness, permanent disability or death.**

**C. Waiver and Release and Indemnification.** In consideration of the Civilian Marksmanship Program's permission to participate in the Advanced Maintenance Class, I hereby release and agree to indemnify and hold harmless the Civilian Marksmanship Program,

its agents, officers, employees, and volunteers (1) from any and all liability connected with my participation in said program; (2) from all actual or potential claims, attorney's fees, costs, for injuries and damages, whether known or unknown, foreseen or unforeseen to the fullest extent permitted by law and (3) from any claim, demand, cause of action for illness, death, injury, damage to my person or property or both as a result of or relating to my participation in the Advanced Maintenance Class. **This means that I am agreeing to release CMP from any liability connected with my participation in the Advanced Maintenance Class and that I will repay CMP if it is found liable to anyone else because of my actions or inactions connected with said class. This also means that I am giving up every right to make any kind of claim against CMP or anyone connected with CMP no matter what the claim is. This release and waiver includes things that could happen even if no one thought about them at the time or someone knew about them already but did not tell me. This also means that I am giving up any claim against CMP if my property is damaged or I am injured, permanently disabled or die as a result of the simple negligence or fault of the Civilian Marksmanship Program, or anybody who is connected with it, including acts by other Advanced Maintenance Class participants. I am giving up these rights to the fullest extent permitted by law. I understand that I am not giving up the right to impose liability upon CMP for its own gross negligence or intentional acts which might cause injury or death to me.**

I also understand that the Civilian Marksmanship Program does not provide financial assistance such as medical, health, or disability assistance, in the event of injury, illness, death, or property damage to attendees. **This means that CMP does not, provide me with any medical, health, disability assistance if I am injured, made ill, die or suffer property damages.**

**D. Insurance.** I understand that the Civilian Marksmanship Program does not carry or maintain health, medical, disability, damage, liability, workers compensation, or other insurance coverage for the benefit of any participant in the Advanced Maintenance Class and I agree that CMP is not obligated to do so. I understand that if I wish insurance coverage I must purchase such coverage at my own expense from a third party. **This means that I am not covered under any insurance held by CMP, and I understand that if I want insurance coverage it is my responsibility to get it and pay for it myself.**

**E. Medical Treatment.** I intend **paragraph C** to include any claim that may arise on account of any first aid or other medical treatment rendered in connection with the Advanced Maintenance Class.

**F. Photographic Release.** I do hereby grant and convey unto the Civilian Marksmanship Program all rights, titles, and interest in and to any and all photographic images and video or audio recording made of me by or on behalf of the Civilian Marksmanship Program or made with its consent, during my participation with the Civilian Marksmanship Program Advanced Maintenance Class I hereby waive and release to CMP and the owners or publishers of any publication or other media in which such are published, any royalties, proceeds, or other benefits derived from the use of such photographs or recordings. **This means that I consent to CMP's use of my photograph, video or audio reproductions of me or my voice, in any way it desires. It further means that I give up any royalties, or benefits resulting from the use of my photograph, video or audio reproductions of me or my voice. I give up any rights I may have under any state or federal law prohibiting the use of my photograph, video or audio reproductions of me or my voice, and waive the provisions of those laws.**

**G. Other.** I expressly understand and agree that this Voluntary Release and Waiver of Liability is to be construed as broadly as permitted by law. I agree that if any clause or provision of this document shall be held to be invalid, such invalidity shall not otherwise affect the remaining provisions of this Release. I also understand and agree that this Release and Waiver is binding upon my executors, administrators, personal representatives, collectors, heirs, successors and assigns. **This means that I agree that this agreement be interpreted as broadly as possible so that my intent to give up ALL claims against CMP, assume the risk of injury or death, consent to the use of my photograph and the rest of the provisions contained in this agreement be carried out as fully as the law allows. If any part of this agreement can not be enforced, it is my desire that the rest of it be fully enforced. I understand that I am agreeing to this agreement for myself and for all of my relatives, anyone who might take care of my estate, my heirs, or anyone who might have a right to make a claim on my behalf.**

**H. Certification.** I understand that CMP is relying on me to have fully read and understood the provisions of this agreement, and to have voluntarily and without mental reservation agreed to them. I hereby certify that I have read, fully understand and agree to each and every provision of this agreement and I intend to be bound by these provisions.

**I. Rifle** I understand that during the conduct of this class that I will be assembling an M-1 Garand Rifle and that I may purchase such rifle. I hereby waive any warranty, express or implied with respect to such rifle and agree to indemnify CMP for any injury to any other person or property as set forth in Paragraph C above involving such rifle.
