



2021 CMP RULES ERRATA SHEET CMP GAMES RIFLE AND PISTOL COMPETITION RULES

2020 CMP Rulebooks were printed in early 2020 shortly before the Covid-19 pandemic caused the cancellation of many 2020 competitions including the National Matches and most CMP Travel Games. Since the 2020 Rules were not used for a full year of competitions and because the CMP has a large inventory of printed 2020 Rulebooks, the CMP will not publish new 2021 Rulebooks, but will continue to use 2020 Rulebooks with errata sheets that list 2021 rule changes. A limited number of rule changes for the next year were approved by the CMP Rules Committee and those changes that concern CMP Games Rifle and Pistol Rules are listed in this Errata Sheet. To use your printed 2020 Rulebook, note or annotate rules in it where changes listed in this Errata Sheet apply.

CHANGES IN 2020 & 2021 CMP GAMES RIFLE COMPETITION RULES

1.2 Open Participation Without Discrimination -- Insert a new Rule 1.2 as follows and renumber Rule 1.0 accordingly

The CMP is a national shooting sports organization chartered by federal law (Title 36 USC, §40701-40733) and dedicated to promoting gun safety, marksmanship training and marksmanship competitions. CMP competitions are open to all competitors who comply with the requirements of federal law (see Rules 2.1, 2.2 and 2.3) regardless of their race, sex, age, sexual orientation or disability.

Rule 1.6.3 Sanctioned Match Requirements -- add a specific requirement that CMP-sanctioned match sponsor must enforce Rule 3.6 safety requirements:

c) *Provide sufficient qualified competition officials to ensure that the requirements of these rules are properly enforced. Failure to effectively enforce Range Safety Procedures in Rule 3.6 may be grounds for not accepting scores fired in a competition for classification purposes or the awarding of EIC credit points or other CMP awards.*

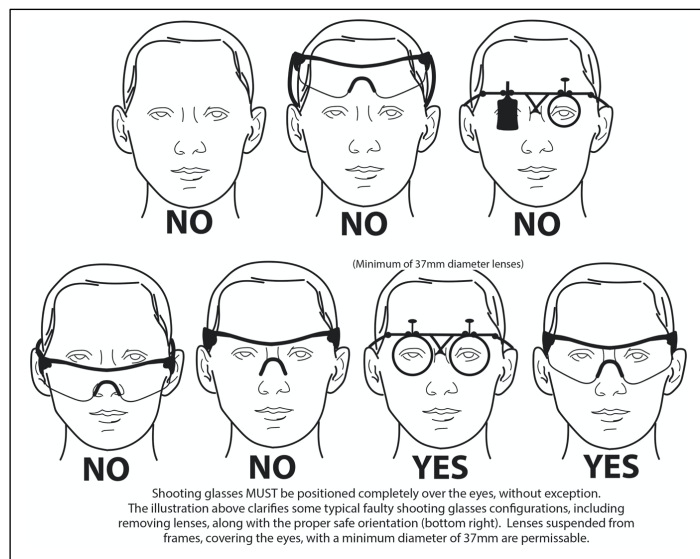
Rule 1.8.7 d) Verifier -- Add a new Verifier responsibility as follows:

d) *Calling out the value of each slow-fire shot and rapid-fire total when they are signaled from the pits, unless the competitor instructs the Scorer not to call out shot values or scores.*

Rule 3.1.2 Eye and Hearing Protection

– The rule requiring the wearing of eye and hearing protection during firing was clarified with the following new text and illustration:

All competitors and competition officials, including Scorers or Verifiers, are required to wear eye and hearing protection when on shooting range firing lines during pistol firing. Eye protection must have two complete lenses with minimum dimensions in depth and width for each lens of 1.30 in. It is strongly recommended that eyewear worn on firing lines meet or exceed the



ANSI Z87.1 safety standard impact protection. Competitors' eyewear must be worn so that the two lenses remain in front of the eyes during firing (see diagram). No one will be allowed to participate in a CMP-sanctioned competition unless they are wearing eyewear and hearing protection that complies with this rule. Any competitor or match official who is not in compliance with this rule will be warned in accordance with Rule 3.12.2 a). Refusal to comply with a warning is grounds for disqualification.

Rule 3.6 Rifle Slings -- Amend Rule 3.6 to authorize the use of M1923 leather slings: Insert "M1923 leather" or "M1923" as appropriate.

Rule 3.7.2 Call to Line and Preparation Period -- Amend Rule 3.7.2 to eliminate the pre-prep period when there is no position change:

After each relay of competitors is called to the firing line and before each firing stage where a firing position change is involved, there must be ~~an interval~~ a pre-preparation period of two (2) minutes (see chart below). ~~There must be followed by~~ a Preparation Period of three (3) minutes when competitors can prepare for firing before every stage.

The Range Officer script must also be changed to reflect the deletion of the two-minute pre-prep period when no firing position change is involved.

Rule 5.2.6 Unlimited M1 Garand -- Delete the 10.5 lb. weight limit for Unlimited M1 Garands:

Delete "~~weigh no more than 10.5 lbs.~~"
