



## 2021 CMP RULES ERRATA SHEET CMP SMALLBORE RIFLE COMPETITION RULES

2020 CMP Rulebooks were printed in early 2020 shortly before the Covid-19 pandemic caused the cancellation of many 2020 competitions including the National Matches and most CMP Travel Games. Since the 2020 Rules were not used for a full year of competitions and because the CMP has a large inventory of printed 2020 Rulebooks, the CMP will not publish new 2021 Rulebooks, but will continue to use 2020 Rulebooks with errata sheets that list 2021 rule changes. A limited number of rule changes for the next year were approved by the CMP Rules Committee and those changes that concern CMP Smallbore Rifle Rules are listed in this Errata Sheet. To use your printed 2020 Rulebook, note or annotate rules in it where changes listed in this Errata Sheet apply.

### CHANGES IN 2020 & 2021 CMP SMALLBORE RIFLE COMPETITION RULES:

**Rule 1.3 Open Participation Without Discrimination** -- Insert a new Rule 1.3 as follows and renumber Rule 1.0 accordingly

*The CMP is a national shooting sports organization chartered by federal law (Title 36 USC, §40701-40733) and dedicated to promoting gun safety, marksmanship training and marksmanship competitions. CMP competitions are open to all competitors who comply with the requirements of federal law (see Rules 3.1, 3.2 and 3.3) regardless of their race, sex, age, sexual orientation or disability.*

**Rule 3.5.4 Club Teams** – Clarify that members of club teams must have been club members for at least 30 day prior to the competition.

**3.5.4 Club Teams.** Club teams must represent a CMP-affiliated shooting club. Club teams may include Junior and Senior competitors. Club team members must have been members of the club they represent for at least 30 days prior to the competition.

**Rule 3.7.3 Distinguished Marksman Authorization.** – Add a new rule allowing smallbore rifle competitors with disabilities to participate in the Distinguished Marksman program. *A Competitor with a permanent disability or limitation who can complete a Smallbore Rifle Three-Position or Prone EIC Match course of fire while using a WSPS SH1 or similar adaptive positions may be authorized to compete to earn EIC credit points that count towards the awarding of the Distinguished Marksman Badge in accordance with Rule 11.4*

**Rule 5.5.2 Kneeling Roll** – Add an authorization for competitors age 55 or older to use a second kneeling roll.

One cylindrical roll placed under the right foot or ankle of the right foot, in the kneeling position is allowed. The roll cannot exceed a maximum of 25cm (10 in.) long and 18cm (7 in.) in diameter. The roll must be made of soft and flexible material. The use of binding or other devices to shape the roll is not permitted. Competitors who are 55 years of age or older may use a second kneeling roll in the kneeling position that is placed between the right heel and buttocks.

**Rule 6.6.1 h) Kneeling Position** – Add the authorization for a second kneeling roll.

h) If the kneeling roll is placed under the right foot or ankle, the foot may not be turned at an angle of more than 45 degrees. Competitors who are 55 years of age or older may use a second kneeling roll that is placed between the right heel and buttocks.
