CMP COMMERCIAL FIREARMS ORDERING INSTRUCTIONS

TO PURCHASE A COMMERCIAL FIREARM FROM THE CMP, A PURCHASER MUST PROVIDE PROOF OF:

- Age: You must provide a copy of a your driver's license to show proof of age.
- Legal Eligibility to Purchase a Firearm: The information 2. you supply on your application will be submitted by the CMP to the FBI National Instant Criminal Check System (NICS) to verify you are not prohibited by Federal, State or Local law from acquiring or possessing a firearm. Your signature on the Purchaser Certification portion of the purchase application authorizes the CMP to initiate the NICS check and authorizes the FBI to inform CMP of the

IMPORTANT: If your State or locality requires you to first obtain a license, permit, or Firearms Owner ID card in order to possess or receive a firearm, you must enclose a photocopy of your license, permit, or card with the application for purchase.

ALL commercial firearm shipments must be made to a Federal Licensed dealer.

All commercial firearm shipments must be made to a licensed dealer and Certificate of Eligibility (COE) (must submit copies with your order form from states that requires a COE). Firearms will only be shipped to an FFL and no C & R holders.

3. Order Form and Purchaser Certification and Agreement: If you think you may purchase additional firearms in the future, we recommend you make several extra copies of the blank forms for use in placing future orders. Customers should complete all three pages of the order form and sign it before a notary.
