

JROTC Postal Electronic Target Procedures

Electronic Scoring Targets (EST) are now authorized for use in the JROTC Postal Competition. This document will govern the use of ESTs and will detail how scores will be reported to the CMP after the match has concluded. Below you will find the requirements

Requirements: The fair conduct of the JROTC Postal Competition is the CMP's top priority. There will be no exceptions made to the requirements listed below. If you are unable to successfully fulfill the following, please register for paper targets to be printed and mailed to your school.

- JROTC Units must have approved ESTs as prescribed in rule 8.1.2 (DISAG, Kongsberg (KTS), Megalink, Meyton, Orion Athena and SIUS AG).
- Coaches must register to use ESTs when registering their team on CMP's Competition Tracker
- CMP Numbers are required when submitting scores to the CMP
 - o Orion Scoring System customers will receive a Virtual Child Match issued by the Civilian Marksmanship Program. Users must have each athlete's CMP Numbers in the "Competitor Number" field in Orion.
- EST users without Orion Scoring System integration will be required to verify the fair conduct of the JROTC Postal by certifying their competition with a competition witness. Failure to do so will result in disqualification.
- Orion customers must download the Virtual Child Match and submit scores by sharing their match directory with CMP when the competition has concluded. Virtual Match Children matches can only be downloaded one time.
- Non-Orion users must submit their athlete's scores using the score submission link provided on the CMP website.

Orion Scoring System Integration (Athena Targets, Sius AG and Megalink)

- EST users with Orion Scoring System should provide their 4-digit Orion account number at registration.
- You will receive an email from the CMP informing you your Virtual Match Child is available for download.
- Download the Virtual Match Child in Orion.
 - o File > New Match > Download a Virtual Match Child
 - o Select "2025 – 2026 JROTC Postal Competition"
 - o Click "Download"
 - o Enter your Team Members in the Match Competitors tab.
 - Enter athletes' names in the Last Name and First Name fields in Orion. The names in Orion must match the names in Competition Tracker.
 - Enter athletes' CMP Numbers in the "Competitor Number" field
 - Select the correct rifle class for each competitor
- Conduct the competition in accordance with the Match Conduct section found in this document.

- Submit Scores to CMP in Orion
 - o Go to *Match > Export Results > Share Match Directory – With Civilian Marksmanship Program*
 - o Submit an EST Unit Firing Report found on the CMP Website.

Non-Orion Electronic Target Procedures (Kongsberg KTS, Meyton, DISAG)

- Register your team to use ESTs during the JROTC Postal Registration on Competition Tracker
- Conduct the competition in accordance with the Match Conduct section found in this document.
 - o A witness must be present to certify the competition.
- Submit Scores using the EST Score Submission Link on the CMP Website
- Submit the EST Unit Firing Report

Match Conduct

All three-position air rifle competitions should be conducted using the National Standard 3-Position Air Rifle Rules (Rule 7.0 Competition Procedures). Procedures for Firing the Postal Competition:

Stage	Activity	Time Limit
Stage 1	Preparation and sighting stage for Prone	8 minutes
Stage 2	Prone Position Rule 5.1.1	10 minutes
Stage 3	Changeover Period	5 minutes
Stage 4	Standing Sighters	5 minutes
Stage 5	Standing Position Rule 5.1.2	15 minutes
Stage 6	Changeover Period	5 minutes
Stage 7	Kneeling Sighters	5 minutes
Stage 8	Kneeling Position Rule 5.1.3	10 minutes
